PAYMENT TERMS AND CONDITIONS:

Tuition for Pleasant Ridge Christian Academy is a one-time fee that must be paid in one lump sum. **Tuition fees are due regardless of the days your child attends.** All holidays have been taken into consideration when setting tuition rates. Students may not attend class or the program they participate in until all fees are paid.

Payments will be set up in your Praxi Parent Portal. They may draw on a Credit Card or direct bank account A.C.H. payment. The convenience fee for credit cards is 3% of the payment amount and 25 cents for A.C.H. payments.

There is a \$35.00 fee for all returned checks and returned A.C.H. payments. Checks are to be brought by the parent to the School Office. **Checks are NOT to be given to the student or the teacher.** We will not be responsible for payments left anywhere other than with our Office Personnel. All accounts must be paid in full before the child will be permitted into the next program (school accounts must be paid in full before the child can attend school the following year). Pleasant Ridge Christian Academy makes every effort to keep the cost of tuition/fees at a minimum.

Pleasant Ridge Christian Academy is a nonprofit institution. All student fees are used for functions and services intended to benefit the students of our school. Our goal is to provide the highest quality instruction and care for your child at the lowest possible cost. Your prompt payment of fees will assist us in meeting this goal.
